

2018 RENTAL CONTRACT
FOR SPOTS WITH 10A ELECTRICITY CONNECTION

RENTAL TERMS AND CONDITIONS

Spots with a 10A electricity connection can be booked on a weekly basis only (other spots do not require booking). Arrival from 1pm, departure by 12 noon (ask us about reception opening hours in the low season.). **Please contact us in the event of late arrivals.** The exact number of guests, the tent, and car, trailer... are included in the price of your camping spot with electricity. Please note: depending on the size of your tent, extra vehicles, trailers or boats may not necessarily fit on your spot and must be left at another part of the campsite.

Visitors must report to the reception on arrival and pay the applicable charges.

Booking conditions

Your reservation is only effective **after we have received your down payment** amounting to 25% of the total for your stay (+18 euros non-refundable administrative fee), payable by credit card or bank transfer, and **once we receive the rental contract** which must be properly filled out and signed (indicating that you accept the clauses and provisions of the RENTAL TERMS AND CONDITIONS). The price of your stay includes the tourist tax.

Your stay must be paid in its entirety before taking possession of your camp spot.

The total amount must be paid 30 days before your arrival. You will not receive any reminders.

We accept dogs on leads upon presentation of their valid vaccination certificate - please see current rates.

Please note:

No reimbursement is available for delayed or shortened stays.

Delays of over 24 hours which have not been indicated by the client by registered mail or fax will result in cancellation of the booking and loss of the total amount of the stay.

Cancelling a booking: All cancellations must be made by registered mail or fax

The administrative fees will not be refunded under any circumstances.

If you cancel more than 60 days before your arrival, the 25% down payment will be refunded to you,

If you cancel between 60 and 30 days before your arrival, the 25% down payment will be retained by the Campo di Liccia campsite

If you cancel within 30 days of your arrival, the entire cost of your stay will be retained by the campsite.

In no event can the management be held responsible for loss of personal items, injury or damage caused to holiday-makers or their belongings during their stay.
