2018 RENTAL CONTRACT

RENTAL TERMS AND CONDITIONS

Accommodation is booked on a full-week basis from Saturday to Saturday in high season, rentals can be made for a minimum of 2 nights in low season for booking call us. Arrivals are from 5.00pm in April, May, September and at 4.30pm in June, July and August. Departures before 10.30am (Contact us for reception opening hours in the low season.). Please contact us in the event of late arrivals.

Outside of this period, accommodation can be rented for 2-night stays minimum.

A parking space is included in the price of all rentals. Extra charges will apply in the case of extra vehicles and spots with a trailer or boat (contact us).

Vehicles, trailers, etc. must be parked on the rental spot, or close nearby, depending on the terrain. Tents are not allowed alongside them.

All rentals come with duvets, pillowcases, dishes, garden furniture or wooden table and bench, microwave, deckchair, etc.

Towels and table linen are not provided. Sheets may be rented 6,5€/bed

A one-time supplement must be paid for each additional person staying in your accommodation (see current rates).

Booking conditions

Your reservation is only effective **after we have received your down payment** amounting to 25% of the total for your stay ($+ \\mbox{ e18}$ non-refundable administrative fee), payable by credit card or bank transfer, and **once we receive the rental contract** which must be properly filled out and signed (indicating that you accept the clauses and provisions of the RENTAL TERMS AND CONDITIONS). The price of your stay include the tourist tax.

Your stay must be paid in its entirety before taking possession of your accommodation

The amount must be paid 30 days before your arrival. You will not receive any reminders. If you book within 30 days of your date of arrival, you must pay the entire amount when you make your booking.

For each rental type, a deposit is requested on arrival (payable in cash): $\pounds 200 + \pounds 70$ (cleaning deposit) and will be returned to you when your accommodation is checked on the day of your departure. If the accommodation is considered to be insufficiently clean or if any inventory items are missing or damaged, the applicable charges will be taken from your deposit.

We ask that you check the condition of your accommodation rental upon arrival. Please tell us on your first day (or the morning after for late arrivals) if anything is missing, defective or broken. Another check will be carried out upon your departure, and all missing or broken items that you did not notify us about on the day of your arrival will be billed to you on the day of your departure.

Please make an appointment at the reception on the first day of your stay. For departures outside of the planned times or if the hours available do not suit your schedule, the

accommodation must be left in a clean condition (dishes washed and tidied away); if you do not wish to do the cleaning, a \notin 70 charge will apply. If your accommodation is not clean, please let the reception know right away, so that a person can be sent to clean it. No claims will be accepted on the day of your departure.

Animals: . No pets are accepted in the accommodation

Bungalows:

We remind you that the mezzanine sleeping area involves stair access, and that the latter are not suitable for mobility-impaired persons or persons with physical limitations.

Air conditioning:

Our mobile homes, chalets and bungalows are air-conditioned via a programmed card for 49 hours per week or 14 hours for 2 nights. If you use up your allotted time, you can buy a card lasting 7 hours at the reception for $\in 15$. No discount will be given in the event of breakdown of the air conditioning system. The repair lead time will depend on the seriousness of the breakdown, but the matter will be dealt with as quickly as possible in order to minimise inconvenience for guests.

Please note:

No reimbursement is available for delayed or shortened stays.

Delays of over 24 hours which have not been indicated by the client by registered mail or fax will result in cancellation of the booking and loss of the total amount of the stay.

Cancelling a booking: All cancellations must be made by registered mail

The administrative fees will not be refunded under any circumstances.

If you cancel more than 60 days before your arrival, the 25% down payment will be refunded to you,

If you cancel between 60 and 30 days before your arrival, the 25% down payment will be retained by the Campo di Liccia campsite,

If you cancel within 30 days of your arrival, the entire cost of your stay will be retained by the campsite.

In no event can the management be held responsible for loss of personal items, injury or damage caused to holiday-makers or their belongings during their stay.
